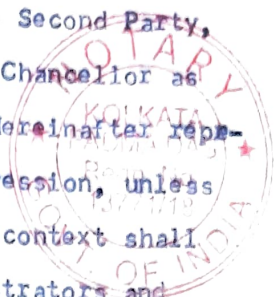

F) The Second Party presently functions from within the campus

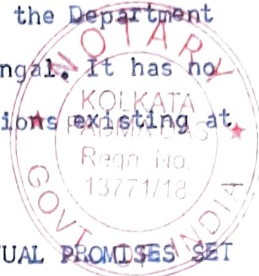
